TOURNAMENT FORMAT: Teams will be placed in a morning or afternoon wave for two days of pool play with all teams advancing into playoffs on the third day. Since it is impossible to determine where a team will finish or how late a team will finish on Monday, teams should make plans to travel in the evening.

- ◆ 15's Division Morning & Afternoon Waves beginning at 8:00 a.m. & 3:00 pm. Wave information will be posted on the RMR website.
- ◆ 14's Division Morning Wave beginning at 8:00 a.m.
- ◆ 13's & 12's Division Morning Wave beginning at 8:00 a.m.

OFFICIALS: First referees will be provided. Teams will need to provide a second referee, two linespersons and two scorekeepers.

CHECK IN: All teams are required to check in at their playing site. Failure to do so may disqualify your team from the tournament. Check-in is Saturday, February 18, 2012 at the Island Grove Facility, Rodarte, Arena and NORCO Facility on Saturday 1 hour prior to the start of play for that wave (7:00 a.m. for morning wave, 2:00 p.m. at All Facilities: Coaches will be given tournament format at check in. Just a reminder, coaches must have proof of Medical Release forms for all players and personal proof of ID for coaching verification (i.e. driver's license). There is no Coaches Meeting.

WAVE ASSIGNMENTS: The AM wave will start at 8:00 a.m. and the PM will begin at 3:00 p.m. for all facilities. The playoff rounds on Monday will begin at 8:00 a.m. Saturday pool information will be posted on the RMR Webpage.

AWARDS: Team awards will be given to 1st Place of each division (Grand Champion, Reserve Champion, Flight 1 and Flight 2). Individual awards will be given to the 1st Place team of the Grand Champion Division for each age group.

MEDICAL STAFF: Players can be taped at the trainers, but you must provide your own tape.

CONCESSIONS & OUTSIDE FOOD: Outside food and drinks will be allowed in all facilities but only in the designated areas. **Outside food or drinks are NOT allowed in the court area of the NORCO Facility and the Arena Facility water only.** If coolers and food are found in undesignated eating areas it will be confiscated! The Island Grove Facility will have a concession stand with a variety of food and drinks available for sale.

Facilities will be cleaned every night, all personal items must be removed from the facilities nightly or they will be thrown away.

PARKING: There is plenty of parking available at no charge around the Island Grove Facility. Parking around the NORCO Facility may be limited especially during the wave change. Please be patient and courteous.

DIRECTIONS

I-25 to Island Grove Regional Park (Courts 1 - 14):

*Hwy 34 to 23rd Ave and turn left going north. Go to 10th St and turn right going east. Turn left onto 14th Ave. and this will take you straight into Island Grove Regional Park.

Hwy 85 to Island Grove Regional Park (Courts 1 - 14):

*Hwy 85 north which turns into 8th Ave, turn left onto 5th St going west. Turn right onto 14th Ave going north and this will take you straight into Island Grove Regional Park.

I-25 to Jesus Rodarte Center (Courts 15 - 16):

*Hwy 34 to 23rd Ave and turn left going north. Go to 10th St and turn right going east. Turn left onto 14th Ave to "A" street, right to address.

Hwy 85 to Jesus Rodarte Center (Courts 15 -16):

*Hwy 85 north to 8th St. and turn left going West. Turn right on 8th Ave, going North. Turn Left on A St, to 920 A St.

I-25 to NORCO Facility Windsor, CO (Courts 17 - 22):

*I-25 to the Crossroads Blvd Exit and head east about 1.2 miles/then turn left on Highland Meadows Parkway and right on Greendale Road.

I-25 to Arena Facility Windsor, CO (Courts 23 & 24):

*I-25 to Windsor Exit 262. East to Fairgrounds Ave. Right .5 miles (Arena Sports on the left next to Providence Ice Arena) "7850 COUNTY ROAD 5"
